THE LIBRARY PROVIDED ACCESS TO 134,179 ITEMS IN ITS COLLECTION, INCLUDING IN-HOUSE AND OUTREACH COLLECTIONS, FOR USE BY THE PUBLIC AT NO CHARGE. THESE ITEMS WERE BORROWED 256,560 TIMES. THE LIBRARY'S PUBLIC INTERNET ACCESS COMPUTERS AND PUBLIC WI-FI WAS USED 33,149 TIMES; THE ONLINE DATABASE WAS ACCESSED 46,809 TIMES; AND 3,172 REFERENCE QUESTIONS WERE ANSWERED.
