THE LIBRARY WAS OPEN TO THE PUBLIC 56 HOURS EACH WEEK AND WAS THE PLACE TO GO FOR 118,123 CITIZENS WHO VISITED OUR LIBRARY IN PERSON AND 99,064 WHO VISITED US ONLINE. THE LIBRARY PROVIDED ACCESS TO 248,246 ITEMS IN ITS COLLECTION, INCLUDING IN-HOUSE AND OUTREACH COLLECTIONS, FOR USE BY THE PUBLIC AT NO CHARGE. THESE ITEMS WERE BORROWED 340,875 TIMES. THE LIBRARY'S PUBLIC INTERNET ACCESS COMPUTERS AND PUBLIC WI-FI WAS USED 97,245 TIMES; ELECTRONIC CONTENT WAS ACCESSED 47,887 TIMES.

THE LIBRARY OFFERED 648 IN PERSON ADULT AND CHILDREN'S PROGRAMS IN WHICH 14,827 CITIZENS ATTENDED. THE LIBRARY OFFERED 10 VIRTUAL PROGRAMS THAT REACHED 13 PEOPLE.
